ORDER

In pursuance to the notification dated 07.11.2022 of the UGC issued in regard to award of Ph.D degree in the University, it is to notify that as per the guidelines of the UGC the following criteria shall be adopted for conducting course for the research scholars in the University:-

- i) The course work shall be treated as preparation for Ph.D. course work examination and include research methodology, biostatistics, research ethics, computer applications, review of published research in the relevant field, training, etc.
- ii) The minimum qualifying requirement for allowing the Ph.D. student to proceed further with the research work shall be successful completion of the Ph.D. course work examination, conducted by the University, to evaluate this course work.
- iii) The Credit requirement for the Ph.D. coursework shall be a minimum of 12 credits, including a "Research and Publication Ethics" course as notified by UGC vide D.O. No. F.1- 1/2018 (Journal/CARE) in 2019 and a research methodology course. The RAC can also recommend UGC recognized online courses as part of the credit requirements for the Ph.D. programme. One (01) credit equals to 15 contact hours for theory-based teaching and 30 hours of contact time for practical or activity-based teaching
- iv) All Ph.D. scholars, irrespective of discipline, shall be required to train in teaching /education/
 pedagogy/writing related to their chosen Ph.D. subject during their doctoral period. Ph.D.scholars
 may also be assigned 4-6 hours per week of teaching/research assistantship for conducting tutorial or laboratory work and evaluations.
- v) A Ph.D. scholar must obtain a minimum of 55% marks or its equivalent grade (≥ 5.5 CGPA) in the UGC 10-point scale in the course work to be eligible to continue in the programme and submit his or her thesis.

- vi) The Department where the scholar pursues his/her research shall prescribe the course(s) to him/her based on the recommendations of the Research Advisory Committee of the research scholar.
- vii) Candidates already holding M. Phil. degree and admitted to the Ph.D Programme, or those who have already completed the course work in M.Phil. and have been permitted to proceed to the Ph.D. in integrated course, may be exempted by the Department from the Ph.D. course work. All other candidates admitted to the Ph.D. programme shall be required to complete the Ph.D. course work prescribed by the Department.
