**Sub:-** Approval of the State Government for starting of new disciplines/courses in Sai Tirupati University, Umarda, Udaipur

Please refer to your letter dated 17.10.2019 vide which proposal has been sent to accord approval of the State Government for starting of new disciplines in the Sai Tirupati University, Udaipur.

In this connection, in exercise of the powers conferred under Section 4 of the Sai Tirupati University, Udaipur Act 2016, the approval of the State Government is hereby accorded for starting of following new disciplines in the Sai Tirupati University, Udaipur from session 2020-21.

The University shall undertake research and studies work in the following disciplines:

1. Management Studies
2. Engineering and Technology
3. Commerce
4. Law
5. Physical Education
6. Computer Science and Application
7. Education
8. Library Science and Informatics
9. Humanities and Social Sciences
10. Dental and Paramedical Sciences
11. Hotel Management, Hospitality and Tourism
12. Journalism, Mass Communication and Media
13. Fine Arts and Performing Arts
14. Basic Applied and Medical Sciences
15. Vocational Studies
16. Fashion and Technology
17. Planning and Architecture
18. Yoga
19. International Business
20. Information technology
21. Homeopathy, Ayurveda and Unani
22. Public and Allied Health.

**This approval is subject to the following conditions-**

1. The land and requisite infrastructure for the new discipline shall be developed as per the norms of the concerned regulating bodies before starting of new disciplines.
2. if required, prior approval of the relevant regulating bodies shall be taken before starting of the New courses.
3. All other norms and conditions of concerned regulating bodies/relevant competent authorities/departments shall be fulfilled.
4. The standard of the syllabus of degrees/diplomas /certificates courses and minimum eligibility criteria shall not be lower than prescribed by the concerning regulating bodies.
5. University management shall follow all conditions of University Act and fulfill all other relevant norms /rules in this regard.
6. The Nomenclature of degree/diploma/certificate shall be as per approved list of UGC under section 22 of the UGC Act.

In addition to the above conditions, as per recommendation the committee constituted to examine the proposal of the university, the following conditions shall also fulfilled before starting of new courses:

1. As on date University is not eligible for NAAC accreditation as the 1<sup>st</sup> batch of Medical and Nursing is to pass out, furthermore University was established in 2016. University have to go for NAAC accreditation as and when eligible for application.
2. There should be separate class rooms as well as laboratories for the commencement of the new courses.
3. Enough space should be provided to faculty members as per norms so that the students may be able to interact with faculty members for academic and research related works.

4. Firefighting systems shall be installed as per National Building Code in all the buildings.
5. Faculty with Required Qualification should be recruited so as to satisfy teacher- student ratio as per norms of UGC/AICTE/ BCI/MCI/NCTE and other regulatory bodies.
